Reaching Out with School-Based Healthcare

In 2017 the Clinic began a conversation within the community about the need for increased healthcare availability for children and youth. We reached out for support from our donors and were overwhelmed by your generosity and true heart for this project. Initial donations helped to create a functional medical and dental clinic at Ashby Lee Elementary School.

Funding to sustain the program was questionable so the Holtzman Oil and Holtzman Propane Companies agreed to match up to \$50 thousand in donations. Community members took on the challenge and approached their friends, their churches, and their civic groups about ways they might contribute.



Whether it was pledging a monthly gift or arranging special benefit events, **each of these efforts added up to the \$50 thousand we needed to obtain the Holtzman matching gift!**

While all the services were utilized, the numbers above illustrate the importance of professional counseling for the children, many of whom have suffered traumas in their personal life — some of whom were suicidal. Grant applications are pending which would facilitate expanding counseling to all the area schools. Efforts are underway to renovate the school space to allow for multiple services to be offered simultaneously – thereby expanding the availability of counseling on that campus as well as flexibility for other services.

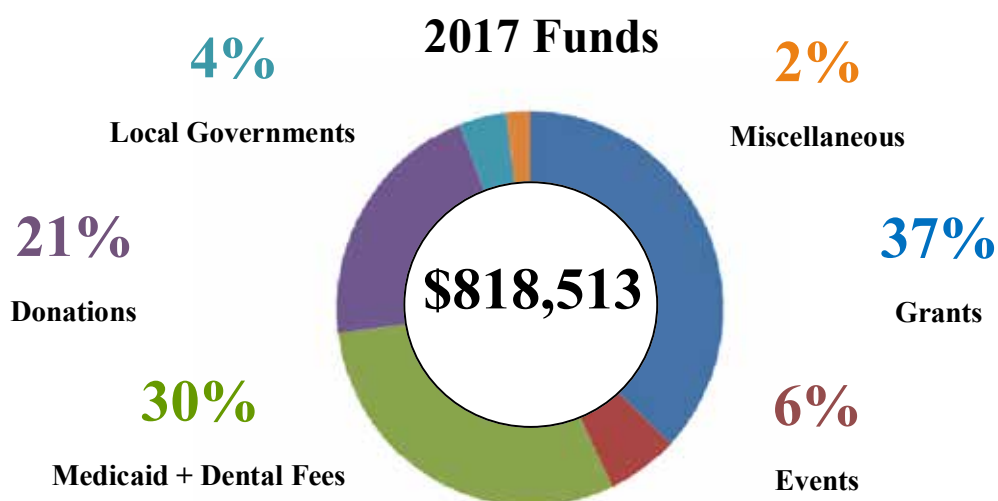

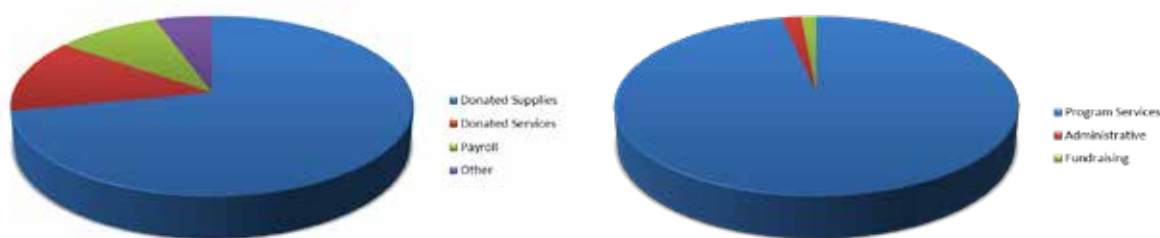
